

**CODE OF CONDUCT**  
**NATURI SUN & HEALTH CLUB INCORPORATED**  
Incorporated in NSW INC2200358



1. Membership to Naturi Sun & Health Club is inclusive and shall be open to families, couples and single people who have declared their belief in, and wish to practice Naturism for health and recreation.
2. Single people may be admitted as vacancies occur subject to approval of the Club Committee and supply of satisfactory character references if sought.
3. Visitors are permitted to wear clothing on their first visit if they so desire.
4. Termination of membership without explanation or refund of fees remains the reserved right of the Executive Committee.
5. All fees become payable upon being accepted for membership and thereafter in advance prior to the start of each Club financial year.
6. Privacy of membership will be respected at all times, members will be known to each other by First names only, no member may publish the name of any other member nor make any statement or disclosure in the name of the Naturi Sun & Health Club to the media without the express approval of the Executive Committee.
7. Photography is not permitted on Club grounds unless authorised by the Executive Committee. No person's photograph may be taken, displayed or reproduced without their prior consent.
8. Club grounds lay within private property. Members must remain inside the defined Club boundaries and may not climb rocks forming part of the perimeter.
9. Access to the Club grounds is by road only and entry must be by vehicle and not on foot.
10. Visitors are only allowed with the prior permission of the Executive Committee.
11. Trees, shrub and plants shall not be cut down or removed from the grounds except with the Executive Committee's approval.
12. Pets cannot be permitted in the grounds under any circumstances.
13. Care and maintenance of the grounds and equipment are normally done by the members to maintain a low level of Club fees and to this end all members will be expected to assist from time to time in the work.
14. Vans are to left clean and tidy after use.
15. Rules and regulations may be formulated or amended from time to time to ensure the orderly operation of the Club by the Executive Committee or its Office Bearers and must be complied with by all members.
16. Members and visitors shall ensure that alcohol is consumed responsibly at all times, and that their behaviour shall not unduly disrupt the comfort of other members or visitors or residents of the property.
17. Only non-greasy sun lotion is to be used, everyone must shower before using the pool to remove excess sun lotion, perspiration etc.
18. Parents are required to be attentive to their children and vigilant to their safety at all times. A parent MUST be with any under-teen child within the pool area at all times. This responsibility may NOT be delegated. All children that are unable to swim must wear a recognised safety floatation device.
19. No glass is to be used within the pool area and food is to be consumed away from the pool.
20. Only sun protective clothing is accepted in the pool area.
21. If, at any time, you feel uncomfortable by any inappropriate remarks or behaviour by any member or visitor, please discuss the issue immediately with a Committee Member.
22. Do not discard cigarette butts around the grounds. Smoking and/or vaping is not permitted in the clubhouse or club vans.
23. Do not light fires outside designated areas. Fires are not permitted on total fire ban days.
24. Members are to take their garbage home.
25. Members are requested to park their cars in the parking areas only. The Executive Committee has the right - at all times - to tell members where and where not to park.
26. Return all equipment - tools, sports equipment, chairs etc. - to their storage space after use.

**CONDITIONS OF MEMBERSHIP**

It shall be accepted that those persons whose signature appear on the membership application agree on their own behalf and on behalf of those children, if any, whose names are shown there, to abide by this Code of Conduct as exists or as formulated or amended from time to time and further agree not to attach responsibility of any kind to any club committee member, or any ordinary club member, for any injury, loss or damage to person or property arising from membership, should the application be accepted.
